Course Overview: This IAS training program is designed to qualify lead evaluators for the IAS Building Department Accreditation program. Participation in this training program is essential for individuals intending to serve on IAS Building Department Evaluation teams. To register for this training, participants must meet the following:

Team Leader - Minimum Qualifications:

Education/Experience

- Possess degree from an accredited university or college with eight years experience working in a municipal inspection or similar agency; or
- Possess ICC certification as a CBO and/or have five years of experience as a Building Official/Manager of a building inspection department, or
- Possess ten years experience or equivalent as an architect, engineer, inspector, contractor or superintendent of construction or any combination thereof, five years of which shall have been at the supervisory level
- Possess excellent oral and written communication skills
- A combination of experience and education deemed acceptable to the IAS Board Committee on Building Department Accreditation

Additional Preferred Qualifications

- At least two ICC certifications in any relevant discipline or a combination of ICC certifications and experience
- Service on an ICC Code Committee, Board and/or an ICC chapter as a board member or other government board or committee
- Attendance at ICC annual business meetings and/or code hearings or active participation in development of safety building/fire codes
- Participation in the adoption of the International Family of Codes

Please note: Registration is on a first-come first-served basis. The number of participants is restricted to ensure a trainer/student ratio that will facilitate effective training outcome. Applicants admitted to the training program will receive written acknowledgment prior to September 12, 2008.
