FEE SCHEDULE FOR THIRD-PARTY PERMITTING, PLAN REVIEW AND INSPECTION SERVICE PROVIDERS ACCREDITATION ^{1, 2, 3}

REACCREDITATION APPLICATIONS (2-YEAR PERIOD)

Basic Fee.....	\$3000
Additional Branch Offices (fee per office)	\$1500

¹ IAS will furnish a written cost estimate upon request by an applicant.

² Additional fees will apply based on complexity and number of jurisdictions served by the third party.




³ Accredited third-party service providers are subject to on-site surveillance after the first year and re-evaluation at a minimum of once every two years.

NOTES:

1. On-site time of \$1000 per 8-hour day per assessor, plus related travel expenses (at cost), is applicable for pre-evaluation, full evaluation, site visit to jurisdiction(s), follow-up, surveillance, and re-evaluation visits. Additionally, travel time is billed at the rate of \$700 per 8-hour day, pro-rated for travel less than 8-hours. Site visits to jurisdictions served are mandatory. The number and duration of site visits to jurisdictions will be determined on a case-by-case basis. Preparation time for evaluations is included in the accreditation fee.
2. All Corrective Action Requests (CARs) generated during pre-evaluation, full-evaluation, surveillance or re-evaluation visits must be satisfactorily resolved and Concerns generated must be satisfactorily addressed prior to issuance of the accreditation certificate. In some cases, repeated exchanges of communication may be necessary to close out CARs and Concerns. When more than four (4) hours of IAS staff time are needed to resolve CARs and Concerns, an additional fee of \$125 per hour, or fraction thereof, will be charged.

All fees listed in this schedule apply to applicants located in North America (U.S.A., Canada and Mexico). For a breakdown of fees for applicants located outside of North America, please contact us at 562-364-8201.
