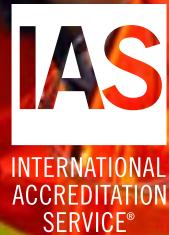

## Welcome to the Special Inspection Agencies Accreditation Program Newsletter!

Welcome to the IAS Newsletter on the SIA Accreditation Program. This newsletter is intended to inform IAS customers about developments at IAS and in the industry that may impact your accreditation and business.

### Frequent Corrective Action Requests

One of the most frequent corrective action requests in special inspection agency assessments relates to internal audits and management reviews. The accreditation criteria (AC291) states:

*4.16 Internal Audit: Policies and procedures for internal audits shall be documented and implemented by the SIA. Records of internal audits and corrective actions shall be available for review. Note: For agencies with no additional qualified internal auditors, such internal audits may be performed by an independent qualified individual.*

Additionally, AC291, section 4.17 Management Review, states that the management review shall, at a minimum, take account of AC291, section 4.17.1, internal audit reports.

IAS has found that although most special inspection agencies conduct internal audits, a frequent finding is that the results are not included in management review discussions. The agencies should maintain records of their internal audit findings and any corrective actions taken. During the management review, those records should be discussed to see that the corrective actions were adequate to capture opportunities for improvement. This information would need to be recorded in the minutes and noted as action items for the next management review.

Another corrective action request frequently found is an oversight of upper management in supervising and monitoring special inspectors in the field and ensuring that their relevant training is completed.

AC291 states:

*4.7 Technical Competency of Special Inspectors: A matrix matching inspector qualifications, certifications, and relevant experience to categories in which they are authorized to conduct special inspections shall be maintained. Inspector's education, certification(s) and relevant documented experience shall satisfy the requirements of the AHJ or Table 1 (if none are specified). The matrix shall include the date of employment and expiration dates for certifications (if any).*

Records need to be kept regarding "the competence requirements, education, qualification, training, technical knowledge, [and] hands-on skills" and need to be "demonstrated onsite or by interview and mock demonstration" as stated in AC291. Any findings need to be addressed and corrected by proper additional training and kept in a matrix.



### IAS moves into a new office

## How are IAS Accreditation Criteria Updated

If your company is accredited to any IAS accreditation program, then you are aware that there is an Accreditation Criteria (AC) for the program. The Special Inspection Agency Accreditation is based on [AC291](#). IAS follows a process that allows for updates to be made to the criteria, as needed. Anyone interested in submitting a proposed change to the criteria can submit their proposed language change to IAS anytime. IAS will bring the proposed language before the Accreditation Committee in a public forum that allows for open discussion. The committee may decide to accept, reject, or edit the proposed language. ## Training on Special Inspection Agency Accreditation

## Need to update your contact with IAS?

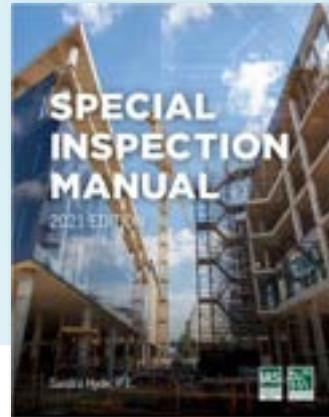
At one point or another, most accredited companies will need to know how to replace the person(s) they have entered into the IAS Portal to receive information about their accreditation from IAS.

The IAS Portal is set up so that each accredited customer has three contacts who receive information from IAS. These contacts are for the customer's Technical Contact, Billing Contact, and Legal Contact. Customers may use the same person, or different individuals, for each of the three contact roles. Each contact has their own login credentials. To update a contact, the customer must log in and make the change. That is why multiple people in your company should have access to the login information. ## Special Inspection Manual

The Special Inspection Manual is published by the International Code Council (ICC) and provides detailed guidance on required special inspections and structural observation. The Manual outlines the special inspections mandated by the International Building Code® and its referenced material standards, with descriptions of those inspections. It also includes information on creating a special inspection overview program within a building department, including procedures and forms to support program administration.
