This newsletter was created to keep IAS customers and industry professionals informed about important developments related to the IAS Inspection Agency Accreditation Program that may have an impact on your organization and its accreditation.

IAS accredits various types of organizations that perform inspections of materials, products, installations, processes, or services. This accreditation process is based on ISO/IEC Standard 17020 Conformity assessment – Requirements for the operation of various types of bodies performing inspection and includes an assessment of each agency's competence to perform inspections and the consistency of their inspection activities.

Accredited inspection bodies benefit from:

- ✓ Prompt, personalized service from IAS, including flexible and timely scheduling of assessments.
- ✓ Internationally recognized accreditation that serves as a "stamp of approval" for industry and regulators.
- ✓ Greater recognition and acceptance of inspection reports across domestic and international borders.
- ✓ Cost savings for manufacturers and exporters by reducing or eliminating the need for reinspection in other markets.

The IAS Inspection Agency Accreditation Program is recognized globally, as IAS is a signatory to the Mutual Recognition Arrangement (MRA) with the International Laboratory Accreditation Cooperation (ILAC). The MRA supports international trade by promoting confidence and acceptance of accredited inspection reports and certificates.

Frequent Findings from Accreditation Assessments

The IAS accreditation process can be a valuable opportunity for inspection agencies to identify areas for improvement and to reduce or prevent risks. A review of common assessment findings can help agencies better prepare for future assessments.

During recent IAS assessments of inspection agencies, the most frequently identified findings were related to:

◆ Authorization and ongoing monitoring of inspectors

- ◆ Per Clause 6.1.5 of ISO/IEC 17020, all inspectors shall be authorized to carry out the specific inspection activities and should be observed on-site unless there is sufficient documented evidence demonstrating their continued competence. Authorization should be based on the inspector's knowledge, training, experience, and qualifications, where applicable, to ensure compliance with the competency requirements of the inspection agency.
- ◆ According to Clause 6.1.9 Note 2 of ILAC P15, on-site observation should be conducted at least once during each accreditation reassessment cycle, that is, every two years. The inspection agency is expected to establish and implement a monitoring plan to ensure timely evaluation of all inspectors. If an inspector consistently demonstrates satisfactory performance, including technical proficiency and sound judgment, the frequency of monitoring may be reduced.
- ◆ The inspection agency shall maintain complete and up-to-date authorization and monitoring records for each inspector.

◆ Calibration or verification of inspection equipment

- ◆ The inspection agency shall ensure the suitability of all the equipment used for the inspection through periodic calibration or verification (Clause 6.2.3 of ISO/IEC 17020). According to Clause 6.2.6 of ISO/IEC 17020, measurement equipment having a significant influence on inspection results shall be calibrated before use.
- ◆ If any equipment is not under the direct control of the inspection agency (e.g., client's equipment), the inspector shall verify the calibration status or its function to ensure they meet the requirements of inspection procedures and standards, and the equipment information and verification should be documented. Hence, the inspection agency should identify which equipment requires calibration and select an accredited calibration laboratory to perform the calibration and establish the calibration program to ensure the equipment is calibrated in a timely manner.

Additionally, less frequent findings included:

- ◆ Inadequacies in inspection procedures and recordkeeping
- ◆ Inspection reports lacking key elements required by the applicable standards
- ◆ Delays in addressing findings raised during internal audits and insufficient analysis of risks to impartiality

These findings highlight critical areas where corrective actions are necessary to ensure that the inspection agency maintains impartial, effective, and reliable operations—and consistently delivers valid and accurate inspection services in full compliance with the requirements of ISO/IEC 17020.

Extending Your Scope of Accreditation?

Inspection agencies often extend the scope of their accreditation to service a broader range of customers who may wish to use their inspection services. If you plan to expand your scope, it is important to inform IAS before assessors arrive at your regularly scheduled assessment.

IAS assessors plan their work in advance, based on the number of fields and the range defined in your current scope. If you plan to extend the scope of your agency, they might need additional time during their visit. By notifying IAS in advance, the scope extension may be more easily accommodated, helping to avoid scheduling issues and unnecessary costs—and making the assessment process more efficient.





How IAS Accreditation Criteria Are Updated?

If your agency is accredited under the Inspection Agency Accreditation Program, you are likely familiar with the IAS Accreditation Criteria ([AC98](#)) for this program.

To update these criteria, IAS follows a structured process that allows for periodic revisions as needed. Any interested party may propose changes at any time by submitting written revisions to IAS, along with the rationale for the proposed changes. The proposals are reviewed before the IAS Accreditation Committee in a public forum that includes an open discussion session. Following the review, the committee may accept, reject, or modify the proposed revisions.

The most recent IAS Accreditation Committee meeting was held on June 11, 2025.

Revision of ISO/IEC 17020—Fundamental Accreditation Standard of Inspection agencies

In December 2022, ISO/CASCO voted to revise ISO/IEC 17020 *Conformity assessment — Requirements for the operation of various types of bodies performing inspection*. As a result, ISO/CASCO Working Group 31 was established to lead the revision process.

After initial development phases (Working Draft and Committee Draft), the Draft International Standard (ISO/IEC DIS 17020) was released for balloting with deadline of May 2, 2025. If comments from the DIS ballot result in significant changes, a Final Draft International Standard (FDIS) is expected to be released for ballot in October or November 2025. The final revised version of the standard is anticipated by late 2025 or early 2026.

Key changes in ISO/IEC DIS 17020: include:

- **Title update:** The title has been simplified to *Conformity assessment — Requirements for bodies performing inspection*
- **Management system requirements:** These now align with ISO/CASCO PRO33, which calls for harmonized structure and language across ISO/CASCO standards. New requirements address impartiality, confidentiality, complaints, competence, appeals, and management systems. References to Option A and Option B have been removed, and the frequency of internal audits and management reviews is now left to the discretion of the inspection agency.
- **Impartiality requirements:** Independence requirements have been removed. All inspection bodies, regardless of their organizational structure, must meet the same impartiality requirements.
- **Types of inspection bodies:** A new classification, “non-Type A,” has been introduced to combine the previous Type B and Type C categories from ISO/IEC 17020:2012.
- **Validation of inspection procedures:** Stricter requirements are now in place for validating non-standard inspection methods, using language similar to that found in ISO/IEC 17025:2017.
- **Sampling:** Sampling is now treated as a distinct inspection activity or a core part of some inspections, with expanded requirements and greater emphasis.
- **Artificial Intelligence (AI):** AI is acknowledged as an emerging tool in inspection activities. While no detailed requirements have been established due to its evolving nature, it is referenced in the standard.
- **Risk management:** A new clause has been added to address actions for managing risks and opportunities, consistent with the approach of ISO/IEC 17025:2017.

The International Laboratory Accreditation Cooperation (ILAC) will determine the transition period for the new standard during its General Assembly meeting in October 2025. Traditionally, ILAC allows a three-year transition period for newly published international standards.

More information will be shared with all interested parties once ILAC announces the official transition period.

Need to Update Your Contact with IAS?

Most accredited organizations will eventually need to update the contact person(s) listed in the IAS Portal. Each accredited customer has three designated contacts who receive communication from IAS: a **Technical Contact**, a **Billing Contact**, and a **Legal Contact**. Although some customers use the same person for all three designations, it is best to assign a different individual to each role.

Each contact has their own login credentials. To update this information, customers must log in to the IAS Portal and make the change directly. It is important to keep these details current—and to ensure more than one individual in your organization has access to the login information.

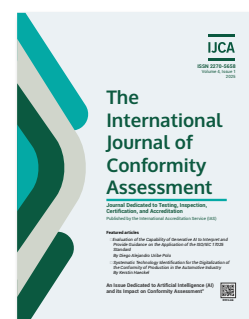
